

## HERSHEYPARK SEASON PASS HOLDER LOYALTY PROGRAM TERMS AND CONDITIONS

**Effective Date: July 11, 2025**

PLEASE CAREFULLY READ THESE HERSHEY PARK AMUSEMENT PARK SEASON PASS HOLDER LOYALTY PROGRAM ("PROGRAM") TERMS AND CONDITIONS. INDIVIDUALS WHO HAVE A VALID 2025 HERSHEY PARK SEASON PASS OF VALUE ARE ELIGIBLE TO PARTICIPATE IN THE PROGRAM ("PARTICIPANTS").

PARTICIPANTS AND PARTICIPANTS' PARENTS OR LEGAL GUARDIANS, IF APPLICABLE, ACKNOWLEDGE HAVING READ THESE TERMS AND CONDITIONS AND AGREE TO BE BOUND BY THEM AND THE DECISIONS OF HERSHEY ENTERTAINMENT & RESORTS COMPANY WHICH ARE FINAL, AND FURTHER WAIVE ANY RIGHT TO CLAIM AMBIGUITY IN THESE TERMS AND CONDITIONS. IF PARTICIPANTS OR PARTICIPANTS' PARENTS OR LEGAL GUARDIANS, IF APPLICABLE, DO NOT AGREE TO THESE TERMS AND CONDITIONS, THEY SHOULD NOT PARTICIPATE IN THE PROGRAM OR ACCEPT AND/OR REDEEM ANY OF THE PRIZES.

### **1. Program Terms and Conditions and Administration.**

These Program Terms and Conditions apply to each Participant's access to, and participation in, the Program, which is operated by Hershey Entertainment & Resorts Company, 27 W. Chocolate Avenue, Hershey, PA 17033 ("HE&R"). These Terms and Conditions do not alter in any way the terms or conditions of any other agreement a Participant may have with HE&R for other products or services, including any agreement related to the purchase and use of their Season Pass(es). If this Program is promoted or administered on Facebook, X, Instagram, or any other social media platform (collectively "Social Media Platforms"), Participants understand that it is in no way sponsored, endorsed, or administered by, or associated with those Social Media Platforms.

### **2. Eligibility.**

Individuals who have a valid 2025 *Hersheypark* amusement park Season Pass of value, including Bite Size, Snack Size, Full Size, King Size, and Giant Size season passes are eligible to participate in the Program. Pre-K Passes and *Summer Fun* Card holders are not eligible to participate in the Program. Employees and vendors of HE&R who are able to access and enjoy *Hersheypark* using their valid employee or vendor ID are not eligible to participate in the Program. THE PROGRAM IS NOT TARGETED TOWARDS, AND IS NOT INTENDED FOR PARTICIPATION BY, ELIGIBLE SEASON PASS HOLDERS UNDER THE AGE OF 13. HE&R must have a valid email address for Program Participants. Details about the Program, earned Points (defined in Section 4), and Prizes (defined in Section 5) will be sent via email to the email address associated with the applicable Season Pass(es) ("Participant Email"). To provide a different email address to be used in connection with a

particular Season Pass, please visit Ticketing Services located near the main entrance to *Hersheypark*. The information provided will only be used for the purposes of the Program and as otherwise expressly agreed to by the Participant, subject to HE&R's privacy policy. Additionally, Participants can track their Points via their *HPGO* account in the *Hersheypark* app beginning July 22, 2025. ### 3. **How to Participate.**

Participants will automatically earn Points by Visiting *Hersheypark* between July 11, 2025 and September 1, 2025 ("Program Period"). "Visiting" and "Visits" are defined as a Participant's initial valid entry scan of their Season Pass at the Front Gate to enter the Park on any day during the Program Period. Participants will only receive the applicable Points the first time they scan their Season Pass to enter *Hersheypark* on any day during the Program Period, regardless of how many times they enter or exit the Park.

### 4. **How to Earn Points.**

The Prizes (defined in Section 5) that are available to Participants are based on the number of points that are earned ("Points") during the Program Period, with the exception of the 4x Challenge (set forth in paragraph 4.5 below) which is based on the number of Visits. Earning a Prize is contingent upon fulfilling all requirements set forth in these Terms and Conditions. By Visiting *Hersheypark* during the Program Period, Participants can earn Points as follows:

- 4.1. **Jump Start Entry Points:** Participants will automatically earn **15,000 points** each day they Visit *Hersheypark* from July 11 - July 21, 2025 ("Jump Start Entry Points").
- 4.2. **Park Entry Points:** Participants will automatically earn **10,000 points** each day they Visit *Hersheypark* from July 22 - September 1, 2025 ("Entry Points").
- 4.3. **Challenges:** Participants can earn additional Points on top of the Jump Start Entry Points and Entry Points by completing any or all of the Program challenges set forth below ("Challenge[s]"). The Points for a specific Challenge can only be earned one (1) time during the Program Period.
  - 4.3.1. **Sweet Start Challenge.** Enter *Hersheypark* for the first time that day during *Sweet Start* program hours as follows: (1) before 10:00 AM between July 22 - August 24, 2025, and August 30 - September 1, 2025; or (2) before 11:00 AM between August 25 - August 29, 2025, to earn 10,000 Points.
  - 4.3.2. **Time Shifter Challenge.** Visit *Hersheypark* two (2) days in a row, the first day entering after 5:00 PM and the next day entering before 12:00 PM, to earn 20,000 Points.
  - 4.3.3. **Hat Trick Challenge.** Visit *Hersheypark* three (3) times on the same day of week during the Program Period to earn 30,000 Points.
  - 4.3.4. **Weekday Warrior Challenge.** Visit *Hersheypark* any five (5) or more weekdays (Monday - Thursday) during the Program Period to earn 75,000 Points.

- 4.3.5. **Sweet Streak Challenge.** Visit *Hersheypark* at least five (5) times within seven (7) consecutive days during the Program Period to earn 150,000 Points.
- 4.4. **Bonus Days:** Participants can earn the additional bonus days Points set forth below by Visiting *Hersheypark* on days specifically designated by HE&R as Bonus Days during the Program Period ("Bonus Days").
- 4.4.1. **Bonus Days:** Visit *Hersheypark* during a designated "Bonus Day" and earn an extra **10,000 points**. Participants will be notified via the Participant Email by 1:00 PM on the day of a designated Bonus Day. Designated Bonus Days will be solely determined by HE&R. For example, if, at 1:00 PM on August 20, 2025, HE&R designates August 20, 2025, as a Bonus Day, all Participants who Visit on August 20, 2025, regardless of entry time, will receive the extra 10,000 Bonus Day Bonus Points. Participants also have the option to opt-in to receive text messages at <https://www.hersheypark.com/tickets-and-passes/season-pass-holders/loyalty#sign-up> to receive notifications about Bonus Days. Consent to receive text messages is not a requirement or condition to participate in the Program. Message and data rates may apply. Message frequency varies. Text HELP for help. Text STOP at any time to opt out and a confirmation message will be sent.
- 4.5. **Special Additional Challenge: 4x Challenge.** Visit at least four (4) times during the Program Period and receive the exclusive Prize set forth in Section 5.9.
5. **Prizes.**  
Participants will receive the prizes below based on the number of Points they earned during the Program Period ("Prizes"), with the exception of the 4x Challenge (set forth in Section 4.5 above) which is based on the number of Visits. Participants will receive emails via the Participant Email about their Prizes starting on or about September 8, 2025. EACH LEVEL 1-9 PRIZE AND THE 4x CHALLENGE PRIZE CAN ONLY BE EARNED ONE (1) TIME DURING THE PROGRAM PERIOD. PRIZES, INCLUDING THE GRAND PRIZES (DEFINED BELOW), EARNED OR WON BY PARTICIPANTS UNDER THE AGE OF 18 MUST BE REDEEMED BY A PARENT OR LEGAL GUARDIAN.
- 5.1. **Level 1.** Participants who have earned **10,000 Points** will receive a complimentary Bring-A-Friend *Hersheypark* ticket valid for any *Hersheypark Halloween* public operating day. Level 1 Prize expires on November 2, 2025.
- 5.1.1. \*Bring-A-Friend *Hersheypark* Ticket will be sent to applicable Participants via email. Ticket cannot be traded, sold, or reproduced. Ticket has no cash value, is not redeemable for cash or credit, is not replaceable if lost or stolen, and is non-refundable. Ticket provides one person with free, one-time, one-day admission to *Hersheypark*, subject to the same rights and responsibilities as apply to any other *Hersheypark* guest. Valid for one-time use only until the expiration date of November 2, 2025. Ticket is valid during regular *Hersheypark Halloween* public operating hours. Other restrictions may apply.
- 5.2. **Level 2.** Participants who have earned **25,000 points** will receive a one-time 30% Off Discount for *Hersheypark Supply Co.* that can be used with any purchase of \$50.00 or

more in addition to the Level 1 Prize already received. Level 2 Prize expires on October 5, 2025.

5.2.1. \*Valid only at *Hersheypark* Supply Co. The 30% Off Coupon will be automatically added to applicable Season Passes. To redeem, present valid Season Pass in person at time of purchase. Coupon has no cash value, is not redeemable for cash or credit, is not transferable, is not replaceable if lost or stolen, and is non-refundable. Not valid in combination with any other discounts, coupons, or promotions, including the Season Pass Holder discount. Not valid toward gift card purchases, tax, or as price adjustments on prior purchases. Valid only at time of purchase for one-time use only until the expiration date of October 5, 2025. Coupon cannot be reproduced or sold and is not available for use online. Coupon is valid during regular *Hersheypark* Supply Co. operating hours. Other restrictions may apply.

5.3. **Level 3.** Participants who have earned **50,000 Points** will receive a voucher for one (1) 30-minute Time Play Card valid at *Overlook* Arcade in addition to the Level 1 and Level 2 Prizes already received. Level 3 Prize will be emailed on or about September 8, 2025 and expires on October 5, 2025.

5.3.1. \*Valid only for use at *Overlook* Arcade. Voucher has no cash value, is not redeemable for cash or credit, is not transferable, is not replaceable if lost or stolen, and is non-refundable. Not valid in combination with any other discounts, coupons, or promotions, including the Season Pass Holder discount. Not valid toward gift card purchases, tax, or as price adjustments on prior purchases. Valid only at time of purchasing a Time Play Card in person for one time use only until the expiration date of October 5, 2025. Voucher cannot be reproduced or sold and is not available for use online. Time Play Cards are valid any day during regular *Hersheypark* operating hours of the 2025 public operating season. Lost or stolen Time Play Cards cannot be refunded or replaced. Other restrictions may apply.

5.4. **Level 4.** Participants who have earned **75,000 Points** will receive a voucher for a Free *Dark Nights* Tasting Pass item from one of the Tasting Pass participating locations in addition to the Level 1-3 Prizes already received. Level 4 Prize expires on October 5, 2025.

5.4.1. \*Valid for one item on the *Dark Nights* Tasting Pass. Voucher will be automatically added to applicable Season Passes. To redeem, present valid Season Pass in person at time of purchase. Voucher has no cash value, is not redeemable for cash or credit, is not transferable, is not replaceable if lost or stolen, and is non-refundable. Not valid in combination with any other discounts, coupons, or promotions, including the Season Pass Holder discount. Not valid toward gift card purchases, tax, or as price adjustments on prior purchases. Valid only at time of purchase for one-time use only until the expiration date of October 5, 2025. Voucher may not be reproduced or sold. Voucher is valid during regular *Hersheypark Halloween* public operating hours. Other restrictions may apply.

5.5. **Level 5.** Participants who have earned **100,000 Points** will receive a voucher for Buy One, Get One Free flatbread or handheld item at *The Chocolatier* Restaurant, Bar +

Patio in addition to the Level 1-4 Prizes already received. Voucher will be sent via email on or about September 8, 2025. Level 5 Prize expires on October 5, 2025.

5.5.1. \*Valid only for one (1) use at *The Chocolatier* Restaurant, Bar + Patio. Free item must be of equal or greater value. To redeem, present valid Season Pass in person at time of purchase. Voucher has no cash value, is not redeemable for cash or credit, is not transferable, is not replaceable if lost or stolen, and is non-refundable. Not valid in combination with any other discount, coupon, or promotion, including the Season Pass Holder discount. Valid only at time of purchase for one-time use only until the expiration date of October 5, 2025. Voucher may not be reproduced or sold. Voucher is valid during regular *The Chocolatier* Restaurant, Bar + Patio operating hours. Other restrictions may apply.

5.6. **Level 6.** Participants who have earned **150,000 Points** will receive an offer for discounted tickets to select 2025-2026 *Hershey Bears* hockey games in addition to the Level 1-5 Prizes already received.

5.6.1. \*Email will be sent on or about September 8, 2025, with a link to purchase discounted tickets to select 2025-2026 *Hershey Bears* games. Offer is based on availability with limited inventory. Link to purchase select discounted 2025-2026 *Hershey Bears* tickets will expire September 21, 2025. Discounts will vary by game. Discount has no cash value, is not redeemable for cash or credit, is not transferable, is not replaceable if lost or stolen, and is non-refundable. Not valid in combination with any other discounts, coupons, or promotions, including the Season Pass Holder discount. Not valid toward gift card purchases, tax, or as price adjustments on prior purchases. Valid only at time of purchase for selected hockey game. Discount cannot be reproduced or sold. Other restrictions may apply.

5.7. **Level 7.** Participants who have earned **175,000 Points** will receive a voucher for one (1) Free King Size Shake at *Simply Chocolate* dessert stand in *Hersheypark* in addition to the Level 1-6 Prizes already received.

5.7.1. \*Voucher will be automatically added to applicable Season Passes. To redeem, present valid Season Pass in person at time of purchase, only at *Simply Chocolate*. Voucher has no cash value, is not redeemable for cash or credit, is not transferable, is not replaceable if lost or stolen, and is non-refundable. Not valid in combination with any other discount, coupon, or promotion, including the Season Pass Holder discount. Valid only at time of purchase for one-time use only until the expiration date of October 5, 2025. Voucher may not be reproduced or sold. Voucher is valid during regular *Hersheypark* operating hours. Other restrictions may apply.

5.8. **Level 8.** Participants who have earned **200,000 Points** will receive an All Day, Season Pass Loyalty Challenge *Fast Track* Voucher that will allow them to enter the attractions listed below one (1) time using the designated *Fast Track* lane in addition to the Level 1-7 Prizes already received. Valid only for one-time use only until the expiration date of October 5, 2025.

- 5.8.1. \*All Day, Season Pass Loyalty Challenge *Fast Track* Voucher valid for one (1) use on each of the following *Fast Track* attractions: *Candymonium*, *Skyrush*, *Wildcat's Revenge*, *Great Bear*, *Lightning Racer*, *Hershey Triple Tower*, *Trailblazer*, and *Twizzlers Twisted Gravity*. Voucher has no cash value, is not redeemable for cash or credit, is not transferable, is not replaceable if lost or stolen, is non-refundable, and cannot be upgraded. Applicable Participants will receive an email with a voucher to redeem at HPGO kiosks inside *Hersheypark*. Voucher may not be traded, sold, or reproduced. To redeem, upon entry to *Hersheypark*, visit any in-Park HPGO kiosk to scan the voucher and receive an HPGO wristband. HPGO kiosks are available throughout the Park. Subject to all requirements and restrictions for each attraction, including height requirements and health recommendations.
- 5.9. **Level 9.** Participants who earn **250,000 Points** will receive an invitation to a lights-on behind-the-scenes tour of the new *Dark Nights* house, *Kill 'N Fill Garage*, on September 14, 2025, in addition to the Level 1-8 Prizes already received.
- 5.9.1. \*Email with an entry voucher will be sent to qualifying Season Pass Holders on or about September 8, 2025. The lights-on house tour will take place on Sunday, September 14, 2025. Voucher has no cash value, is not redeemable for cash or credit, is not transferable, is not replaceable if lost or stolen, is non-refundable, and cannot be upgraded. Voucher may not be traded, sold, or reproduced. Subject to all requirements and restrictions for the haunted house attraction, including height requirements and health recommendations.
- 5.10. **Special Additional Challenge: 4x Challenge Prize.** Each Participant who completes the 4x Challenge by Visiting at least four (4) times during the Program Period will receive a voucher for a free custom Season Pass Holder bottle sticker. To redeem, upon entry to *Hersheypark*, present the voucher and valid Season Pass in person at Guest Services. Voucher has no cash value, is not redeemable for cash or credit, is not transferable, is not replaceable if lost or stolen, is non-refundable, and cannot be upgraded. Voucher may not be traded, sold, or reproduced.
- 5.11. **Special Opportunity for Top Points Earners.** The top ten (10) Participants earning the most Points over the Program Period will have the opportunity to provide a haunted house prop ("Prop") to HE&R that will be featured in the new *Kill 'N Fill Garage* haunted house during the 2025 *Hersheypark Halloween Dark Nights* experience and future applicable *Hersheypark Halloween* seasons.
- 5.11.1. The Prop must be smaller than 24" x 24". The Prop may not include: (1) profanity, nudity, or material deemed inappropriate or offensive to HE&R; (2) false or defamatory statements about any person or any third party; (3) third party trademarks which suggest affiliation with any trademark owner without permission of such owner or that dilute the value of any trademark; or (4) obscene, indecent, violent, sexually explicit, abusive, discriminatory, racially inflammatory, or other morally or legally objectionable depictions of material, in the sole opinion of HE&R. HE&R retains the right to reject any Prop that does not comply with these requirements.

5.11.2. HE&R will provide Prop drop-off instructions to qualifying Participants. Once provided to HE&R, the Prop will become the sole and exclusive property of HE&R, will not be acknowledged or returned, and cannot be changed, altered, revised, or modified. Participant understands and agrees that the Prop may be used by HE&R in any manner HE&R sees fit, without notice to, credit to, or approval by the Participant. Participant's provision of the Prop to HE&R grants HE&R and its agents an unlimited, worldwide, perpetual, royalty-free license and right to publish, use, edit, adapt, modify, and/or publicly use the Prop in any way in commerce and in any and all media worldwide now known or hereinafter developed, without limitation and without notice or consideration of the Participant.

5.12. **Grand Prizes.** NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE QUALIFYING PARTICIPANTS' CHANCES OF WINNING. Only Participants who have a valid 2025 Season Pass of value that was purchased prior to July 11, 2025, are eligible for this grand prize portion of the Program. Eligible Participants who have earned **350,000 Points** during the Program Period will automatically receive one (1) entry for a chance to be randomly selected to win a free 2026 *Hersheypark* Giant Size Season Pass ("Grand Prize"), which has an approximate retail value of \$485.00. In the event a Grand Prize winner ("Grand Prize Winner") already purchased a 2026 Season Pass prior to July 11, 2025, the Grand Prize Winner will receive a refund for the value the Grand Prize Winner paid for the 2026 Season Pass, regardless of pass size.

- **Odds of Winning a Grand Prize.** The odds of winning a Grand Prize depend solely on the total number of eligible Grand Prize entries earned by eligible Participants and received by HE&R during the Program Period.
- **Selection of Grand Prize Winners.** Five (5) Grand Prize Winners in total will be selected from eligible entries on or about Monday, September 8, 2025, and Grand Prize Winners will be notified within a reasonable amount of time after the selection of the Grand Prize Winners. After the Grand Prize Winners are chosen, alternate(s) will be selected on an as-needed basis in the event that a Grand Prize Winner is ineligible, declines the Grand Prize, or cannot be located. Grand Prize Winner notification will be sent to each Grand Prize Winner via email with instructions for redemption.

Grand Prize Winners and/or a Grand Prize Winner's parent or legal guardian, if applicable, will be required to sign and return a Winner's Affidavit of Eligibility and Release at the time of the award of the Grand Prize, or the Grand Prize will be forfeited.

- **Additional Grand Prize Conditions.** Grand Prize is awarded only to the Grand Prize Winner, is not transferable, and cannot be assigned or given to another person. Grand Prize cannot be traded, sold, or reproduced. Grand Prize has no cash value, is not redeemable for cash or credit, is not replaceable if lost or stolen, and is non-refundable. Grand Prize provides the Grand Prize Winner with free, unlimited admission to *Hersheypark* and Giant Size Season Pass Holder benefits, subject to the same terms and conditions, rights, and responsibilities as apply to any other *Hersheypark* guest and Giant

Size Season Pass Holder. Grand Prize valid for one-time redemption only and must be redeemed prior to January 1, 2026. Grand Prize is valid during regular *Hersheypark* public operating hours during the 2026 operating season. Other restrictions may apply.

HE&R is not responsible for late, lost, damaged, misdirected, illegible, or incomplete electronic transactions and communications, including missed or inaccurate scans of Season Passes. Furthermore, HE&R is not responsible for lost, interrupted or unavailable network, server or other connections, miscommunications, failed telephone or computer hardware or software or other technical failures, unauthorized human intervention, garbled or jumbled transmissions or other errors of any kind, whether human, mechanical or electronic, including without limitation, the incorrect or inaccurate identification of Participant information regardless of cause.

**7. Number of Participants Receiving Prizes.**

With the exception of the Grand Prize, every eligible Participant who successfully earns the Points and/or completes the 4x Challenge as set forth in these Terms and Conditions will receive the applicable Prize(s). The ten (10) top Points earners will have the opportunity to provide the Prop to include in a *Dark Nights* house. Five (5) eligible Participants will win and receive the Grand Prize.

**8. Program Changes and Cancellation.**

HE&R reserves the right to change, modify, discontinue, or cancel the Program or any part of the Program, at any time and in its sole discretion, without notice to Participants.

**9. Publicity Release/Grant of Use.**

By participating in the Program, Participants grant HE&R a non-exclusive, irrevocable, fully paid, universal license to use their name, voice, image, or likeness in any media now known or
